## 10 Answers For When You Are Asked, “Why?”

### I’m Pro-Life because...

1. Science clearly shows that life begins at conception. Conception is the only clear dividing line an individual unique human being and a clump of cells. From that moment on, and until death, it is a unique human person throughout the entire spectrum of human development.
2. Abortion is bad for women. It is emotionally traumatic and physically risky. Women seek abortions, not because they want them, but because they feel they have no other option.
3. The fetus growing in the womb is a distinct and unique human being with its own DNA and its own unimagined possibilities. According to the law of biogenesis, a fetus is clearly a human being and all humans, even the smallest deserve the right to life.
4. I believe in protecting the rights of all people. Pre-born humans are people too! Abortion intentionally denies the pre-born people the right to life and therefore every other right.
5. There is no such thing as an unwanted child.
6. I'm sure that a fetus is a human being but, even if you are not sure, it is best to give the fetus the benefit of the doubt on something so foundational and important as life and death.
7. A child should not be punished for the wrong doings or failures of the mother or father. No parent has the right to chose whether his or her child should die.

9. Abortion is not rare - there are about 3,500 abortions every day in the United States. One-third of my generation died before they had the chance to take one breath. I will not be silent with the breaths I've been given. I survived the possibility of being killed in my mother’s womb. I want to help others survive!
10. I am alive. My mother chose life for me. She gave me a chance to live. I want to help everyone have that chance!



# Top Ten Pro-Life Facts

Here are some very useful facts in discussing abortion. These will be very helpful if you commit them to memory.

1. There are nearly 1.3 million abortions every year in the U.S. That equals about 3,500 Americans aborted every day, and about one abortion every 26 seconds.
2. At the moment of conception the embryo has a complete set of unique DNA and is a human being that is separate from the mother.
3. Each year approximately 163,000 babies are eligible for adoption in the U.S., versus approximately 600,000 couples actively seeking to adopt children.
4. Only 0.53% of abortions fall into the category of a “hard case” – rape, incest, or protection of the mother’s life. Even those cases do not justify the taking of an innocent life.
5. More blacks are killed in the womb at Planned Parenthood facilities in three days than were lynched by the Ku Klux Klan in their entire history.
6. One large-scale study of pregnant rape victims found that approximately 70% chose to give birth. Many sexual assault victims see giving birth as a selfless, love act that helps bring healing from their horrific experiences.
7. Suicide rates for women who have had abortions are 6 times higher than women who have not had abortions.
8. It is estimated that 43% of all women will have at least 1 abortion before they are 45.
9. Abortion is 71 times more common than murder and 13 times more common than rape in the United States.
10. Half of all abortions are committed on mothers 24 years of age or younger.

## Ask the experts

“Planned Parenthood has historic ties to the now-discredited eugenics movement in the United States. More recently, abortionists have worked hard to reach out to minorities. This is reflected in skyrocketing abortion rates among minority women. African-American women account for less than 13 percent of the U.S. population but submit to nearly 37 percent of all abortions.

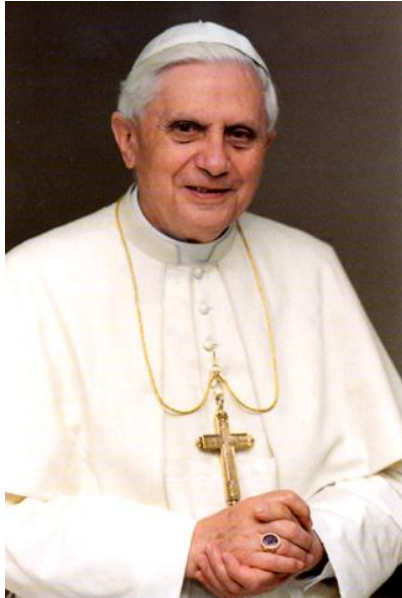

Wade* decision, Professor John Hart Ely, now Dean of Stanford Law School, wrote that the opinion ‘is not constitutional law and gives almost no sense of an obligation to try to be.’ Nowhere do the plain
